VALUE ADJUSTMENT BOARD (VAB) 2014 ORGANIZATIONAL MEETING MINUTES

The Value Adjustment Board (VAB) of Indian River County, Florida, met on Monday, August 11, 2014, at 9:30 a.m., in the County Administration Building, 1801 27th Street, Building "A", Room A-102, Vero Beach, Florida. Present were Commissioner Wesley S. Davis; Commissioner Tim Zorc; School Board Member Karen Disney-Brombach; and Citizen Member Duane Weise. Todd Heckman was absent. Also Present was VAB Attorney Michelle Napier, and VAB Board Clerk Maria I. Suesz; From the Property Appraiser's Office was Supervisor Bruce Goodwin, and Manager Helen "Sissy" Long.

1. CALL TO ORDER

Commissioner Wesley S. Davis called the meeting to order at 9:30 a.m.

2. <u>INVOCATION</u> – Citizen Member Duane Weise

Citizen Member Duane Weise gave the Invocation.

3. <u>PLEDGE OF ALLEGIANCE</u> – Commissioner Tim Zorc

Commissioner Tim Zorc led the Pledge of Allegiance to the Flag.

Commissioner Davis inquired what the rule was regarding missing three VAB meetings in a row, and he commented that this would be the third meeting at which Mr. Heckman was absent. The VAB Clerk Maria Suesz stated that Mr. Heckman had acknowledged that he planned to attend this meeting. 15. APPROVE THE VAB CHAIRMAN TO REVIEW AND AUTHORIZE PAYMENT OF 2014-2015 VAB INVOICES ON BEHALF OF THE FULL BOARD.
