The depositor shall make sufficient proof (copy of photo indentification) to the Indian River County Clerk of the Circuit Court of their ownership to be entitled to receive any part of the moneys so claimed. Unless such moneys are claimed on or before September 1, 2025, the funds shall be declared forfeited to the Indian River County Clerk of the Circuit Court and all claims in reference thereto are forever barred.
