**ORDER GRANTING DEFENDANT SIG SAUER, INC.'S MOTION TO PLACE
INCORRECTLY FILED DOCUMENT UNDER SEAL AND FOR CONFIDENTIALITY**

THIS CAUSE came before the Court (without objection) pursuant to Defendant Sig Sauer Inc.'s Motion to Place Incorrectly Filed Document Under Seal and for Confidentiality filed on November 26, 2025 and after reviewing the motion and being otherwise fully advised in the premises, finds as follows:

1. The Court has Jurisdiction under Fla. R. Jud. Admin. 2.420.
2. The document identified as Sig Sauer Inc.'s Supplemental Responses to Plaintiff's Second Set of Interrogatories dated March 19 2025, filed on November 26, 2025, contains information that is confidential under Rule 2.420 and was filed inadvertently.
3. Good cause exists to seal the document and restrict it from public access.
4. The sealing of the document is the least restrictive means necessary to protect the confidential and privileged information.

IT IS THUS ORDERED and ADJUDGED that the Motion is hereby **GRANTED**. The Clerk of the Court shall SEAL the document titled Sig Sauer Inc.'s Supplemental Responses to Plaintiff's Second Set of Interrogatories dated March 19 2025, filed on November 26, 2025, and remove it from public access. The sealed document shall be viewable only by the Court, the

Clerk and authorized counsel of record for Sig Sauer Inc., unless otherwise ordered. The Clerk has replaced the sealed document with a Notice of Confidential Information in accordance with Rule 2.420. Defendant may refile a corrected or redacted version if necessary.
